These terms of use are a binding legal agreement ("Terms of Use") between you and Nasium Training, LLC ("Nasium Training", "we", "us", or "our") and by registering, logging in, accessing, and/or using any of our courses ("Course") you agree to use the Course and its content only in a manner as stated in these Terms of Use.

The Courses may be provided to you in-person or via the internet through a credentialed website which includes any images, text, code, layouts, displays, or other content in any form including audio or video, or other data including third-party materials, all as may be modified from time to time.

If you are an individual accessing or using the Course on behalf of, or for the benefit of, any entity, you are agreeing to the Terms of Use on behalf of yourself and such organization, and you represent and warrant you have the legal authority to bind such organization to these Terms of Use. References to "you" and "your" in these Terms of Use will refer to both the individual accessing the Course and to any such organization.
